Authority held on 03-08-2016 in the Chamber of the Hon'ble Minister for Transport

The meeting commenced at 02:15 PM and was chaired by the Hon'ble Minister for Transport, who is the Chairman of Kerala Road Safety Authority. The Road Safety Commissioner Shri.Tomin J Thachankary IPS welcomed all the Members and officials. As an introductory speech by the Hon'ble Minister for Transport stated that every work is done as per the Road Safety Guidelines. The Committee has taken decision on the following matters

- It is decided to constitute a Technical Committee in the Kerala Road Safety Authority having members from the departments of Public Works, Motor Vehicles, Police, Health, Law, Finance and NATPAC for strengthening Kerala Road Safety Authority so as to evaluate/vetting each proposal submitted by the Stake Holding Departments/various institutions for placing the same before the Kerala Road Safety Authority for a final decision.
- In the light of the Chief Secretary's query that Road Safety Commissioner should certified all the implemented projects using Road Safety fund are Road Safety related projects, the Committee came to a conclusion that it is not practical since implementation of the projects solely by the Stake Holding Departments. Hence the Committee decided it is the duty of the department itself to assess quality of work such as road works, purchase of road safety equipments, signal installation etc and certify the work done is a road safety related work and submitted along with the detailed

higher officials of the Government unless otherwise government sanction is mentioned.

- As per the Kerala Road Safety Act 2007 section 13 (g), the Committee decided to Purchase appropriate Vehicles for the use of patrolling at Sabarimala at Sabarimala project area (400 km)Season and the rest of the period the vehicles can be used for patrolling, rescuing and other road safety activities as the existing vehicles in the Motor Vehicle Department are very old. And also decided to take up the issue with Government with the proposal "Purchase of Enforcement Vehicles" for which Rs.140 lakhs already sanctioned by KRSA which is pending before the Government.
- It is decided to furnish clarification on recurring expenditure demanded by the Government that the expense will be born by the Motor Vehicles Department
- Also decided to purchase appropriate vehicles suitable for the ghat roads in the forest area using the fund already sanctioned by the KRSA
- The Committee has also decided to submit proposal to Government to release for the balance fund to be transferred to Kerala Road Safety Authority during the year 2008-09 to 2014-15 for Rs.297.65 crores as mentioned by the Principal Accountant General in the Audit Report.
