# Approval of the Minutes of $43^{rd}$ meeting of KRSA held on 08-01-2021 and Action taken on the decisions of the last meeting

The title of Addl. Agenda No. 7 in the 43<sup>rd</sup> meeting was inadvertently mentioned as: "Purchase of electric cars for the officers of Safe Kerala Project" while, the decision of the Authority was *'Hiring of Electric Vehicles for the officers of Safe Kerala Project'*. Since no other comments/remarks were received from the members, the Minutes of the 43<sup>rd</sup> meeting held on 08-01-2021 was confirmed.

# Action Taken on the decisions of the 43<sup>rd</sup> Meeting of KRSA held on 08-01-2021

The Executive Director, KRSA made a presentation of Action Taken on the decisions of the last meeting as listed in the Table in Agenda& Notes. It was informed that actions have been initiated on most of the items sanctioned by the Authority in the last meeting.

The Authority took note of the actions taken on items pertaining to technical scrutiny of the projects referred to Technical Committee of KRSA, Evaluation Committee on Performance of Managerial Officers in KRSA and recommendations of the Centralised Evaluation Committee on purchase of equipment for Police, MVD and proposals of the DRSCs.

# **Project:** Procurement of Traffic equipment for Kerala Police

Deferred and suggested to verify whether sufficient fund available with Police Department in the 'Plan Budget Head' to implement the proposal. It was also suggested that more importance should be given for Safety aspects and to avoid duplication . (Action- KRSA, Police)

**Decision:** Approved. The Authority suggested that a review and monitoring to be done by NATPAC to ascertain whether the devices are placed at the recommended locations.

**Project:** Proposal for Establishment of Traffic Training School and

Research Centre at Kerala Police Academy, Thrissur

Implementing Agency: Police Department.

**Decision:** The Authority suggested that Police Department should ensure funds to meet the cost of infrastructure facilities. Deferred decision and asked a Sub-Committee of the Authority to evaluate the proposal and report. KRSA can only support equipment and setting up Lab: facilities in the Research Centre after the construction of infrastructure.

# Agenda No. 17 (e)

Formation of Self-Help Group under the Authority for rescue operation at the site of accident(s) as per Clause 4 (m) of the KRSA Act 2007

**Decision:** The Authority agreed, in principle, to take this scheme forward and an amount of Rs. 68.20 lakhs for state wide roll out of SOFT(Save Our Fellow Travellers) Scheme is sanctioned. A High-level Committee under Addl. Chief Secretary (Home) involving departments of Home, Health, Transport, PWD, and KRSA be formed to work out the scheme as People's Participatory Programme. A task force should be formed including the Public, School children, Police and already identified 3.5 lakh volunteers and proper training should be imparted.

#### Agenda No.17 (f) Ref: A2/48 /KRSA/2015

Providing assistance to members of public who assist the road accident victims to reach the hospital

**Decision**: The Authority sanctioned Rs.20 lakhs for implementation of the scheme. The Chairman opined that Agenda No. 17 (e) and 17 (f) can be combined together and make it as a state wide 'Janakeeya' Programme. A Task Force is to be formed involving Police, Public representatives, Students Police and the Stake holders to study the scheme and make it as more beneficial to the society.

Hon'ble Chairman (Minister for Transport) and Hon'ble Vice Chairman (Minister for Public Works) will hold a meeting to discuss, this, in detail. The Accident site, some 'Spot Care Unit' and in Transport - in Ambulance Care and Destination Care - Hospital care should be ensured by this committee.

Camera placed by MVD and Police should be in different locations so that on real time basis, data pertaining to these two different locations can be stored and monitored.

# Minutes of the Centralized Evaluation Committee on purchase of digital equipment

**Decision:** Principal Secretary (Transport) informed the decisions of the Centralised Evaluation Committee. The Authority suggested Police and MVD to share digital data/video records from cameras and integrate their digital enforcement. The Authority agreed to recommendation of the Committee to include Comprehensive Maintenance Contract for full life of each electronic devices & digital equipment, instead of AMC, currently followed in purchases. A penal provision for not attending to complaints / fault during the contract period, should be incorporated. It was suggested to have more virtual courts to deal with traffic offences.

The malfunction of Solar Camera installed by M/s KELTRON, based on its down time data, some penal action should be initiated against M/s KELTRON and the same may be reported to next KRSA Meeting.

#### Agenda No. 17 (h)

Emergency Ambulance Vehicle with Advanced Life Support System(ALS) to save accident victims in Golden Hour of treatment

**Decision:** The Authority directed Transport Commissioner to ensure fitment of GPS to all emergency vehicles (ambulances) operating in the state. Also, per K/m rate for private ambulance to be fixed and introduced through some rule by the Motor Vehicle Department. A penal provision should be introduced for violations in this rule.

It asked Health Department to work out networking of public and private ambulance services and to formulate SOP(Standard Operation Procedure) and guidelines for Ambulance Service providers, qualifications for ambulance drivers and fixation of charges for Ambulance vehicles operating in the state and this has to be placed in the ensuing KRSA Meeting.

**Discussion also came up** regarding overloading of goods vehicles and its damaging effect to road pavement. Transport Commissioner explained enforcement actions taken by the department to check over-loaded vehicles on the road from time to time.

The Meeting concluded at 1.00 p.m. with a Vote of Thanks to the Chair.
